

SUMMARY ANNUAL REPORT

For EQUITY-LEAGUE HEALTH TRUST FUND

This is a summary of the annual report of the Equity-League Health Trust Fund, EIN 13-6092981, Plan No. 501, health plan, for period June 1, 2021 through May 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Board of Trustees of the Equity-League Health Trust Fund has committed itself to pay certain claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Anthem Life & Disability Insurance Company, Cigna Health and Life Insurance Company and Affiliates, Health Insurance Plan of Greater New York, Kaiser Foundation Health Plan Inc., Kaiser Foundation Health Plan Inc. and Kaiser Foundation Health Plan of The Mid-Atlantic to pay health, dental, prescription drug, stop loss, HMO and indemnity claims incurred under the terms of the plan. The total premiums paid for the plan year ending May 31, 2022 were \$4,131,644.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$79,920,666 as of May 31, 2022, compared to \$60,990,039 as of June 1, 2021. During the plan year the plan experienced an increase in its net assets of \$18,930,627. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$63,157,763, including employer contributions of \$39,224,067, employee contributions of \$10,694,682, earnings from investments of (\$699,399), and other income of \$13,938,413.

Plan expenses were \$44,227,136. These expenses included \$4,718,217 in administrative expenses, and \$39,508,919 in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
